INTERESTED IN EARNING MORE CONTACT HOURS?

- 60 hours of training are required during the 4-year fire certification cycle.
- By attending Broward BORA's board meetings and/or committee meetings, 1 hour of the required credit will be earned.
- By attending professional association meetings approved by the BORA Staff (i.e. FGAMI, IAEI, COEA), ½ hour of the required credit will be earned for each meeting attended.

BROWARD COUNTY 8TH EDITION OF THE FLORIDA BUILDING AND FIRE CODE AMENDMENTS

The Board of Rules and Appeals <u>adopted</u> the revised <u>Chapter 1 of the 8th Edition (2023) of the Florida Building Code (FBC)</u>. The Broward County Local Fire Code Amendments of the <u>8th Edition (2023) of the Florida Fire Prevention Code (FFPC)</u> were <u>adopted</u> as well.

Both the building and fire amendments became effective on December 31, 2023. The staff reviewed the previous 7th Edition Chapter I, revised the Code or Florida Statute references when needed, and made necessary changes. An effort was made to correct grammatical issues and make Chapter 1 more reader-friendly without changing the meaning of the code sections.

BORA FORMAL INTERPRETATIONS READOPTED FOR THE 8TH EDITION OF THE FLORIDA BUILDING CODE (FBC)

The <u>Board</u> readopted <u>BORA Formal Interpretations</u> (FI) for the 8th Edition of the Florida Building Code (FBC). The Broward BORA staff reviewed and revised the formal interpretations to adhere to the updated code. The staff recommended that the 7th Edition FI-18, "Direct venting of solid fuel pizza ovens," and FI-26, "Location of permanently installed residential standby generator's exhaust," not be renewed.

The Formal Interpretations were effective on December 31, 2023.



NEW: FORMAL INTERPRETATION #34

In <u>December</u>, the Board of Rules and Appeals approved <u>Formal Interpretation #34</u>, Painting of Sprinkler and Cover Plates on Concealed Sprinklers. The Florida Fire Prevention Code, NFPA 1, Section 13.3.3.5.1.6 states:

That sprinklers shall not be altered in any respect or have any type of ornamentation, paint, or coatings applied after shipment from the place of manufacture [25:5.4.1.7].

The Board approved the BORA staff recommendation that sprinkler and sprinkler cover plates shall not be altered by painting as supported by the provisions found in NFPA 1 and NFPA 13.



CONTINUING EDUCATION OPPORTUNITIES

Start off the 2024-2025 certification cycle strong by participating in continuing education opportunities. Twenty-eight educational hours must be completed by the end of the cycle, and at least half of the requirement must be discipline-specific courses. Keep up with the upcoming courses being offered by visiting the <u>Broward BORA website</u> or by contacting a <u>BORA Chief Code Compliance Officer</u>.



Ms. Wolfson is working with State Representative Robin Bartleman to promote this legislation. She made presentations to the Digestive Disease National Coalition and the International Foundation for Gastrointestinal Diseases.

BROWARD BORA ACH PROGRAM REGISTRATION

Broward BORA accepts Automated Clearing House (ACH) Payments. To request enrollment, send an email to Maria "Pat" Kong.

Payments that are processed through ACH are not immediate and may take 2-4 business days to process. To take advantage of the 3% discount, you must submit your payment before the 15th of each month.

To report your online payment to BORA, you must send the following documentation to Maria "Pat" Kong every month:

- 1. Copy of the electronic transaction reporting the total amount made to our account.
- 2. Remittance Advice form with the information about the month reported, showing the deduction of the 3% discount if submitting the electronic payment before the 15th of each month.
- 3. A breakdown showing the minimum \$2.00 charge, if applicable.


2024 BROWARD COUNTY FIRE INSPECTOR EXAM REGISTRATION

The <u>2024 Exam Dates</u> are available for the Broward County Fire Inspector Exam. To qualify for the exam, submit the completed, signed <u>application</u> and policy statement by mail to the Broward County Board of Rules and Appeals or email to <u>Jonda Joseph</u>.

The Broward County Board of Rules and Appeals will pay for first-time test takers to take the Broward County Fire Inspector Exam. A \$60.00 fee will be required to retake the exam by the test taker.

Broward County Code of Ordinances, ARTICLE IX. BUILDING AND CONSTRUCTION, Section 9.02

"Building Code and the Board of Rules and Appeals" mandates that BORA members shall be appointed as follows:

- Seven (7) members and six (6) alternates shall be appointed by the Broward County League of Cities.
- Six (6) members and three (3) alternates shall be appointed by the County Commission.
