An amendment to the Broward Municipal Services District Future Land Use Map Series changing the future land use designation of an approximately five (5) acresite, generally located east of Lyons Road and north of Hillsboro Boulevard and having folio numbers 474232010250, 474232010251, 474232010260, from Estate (1) Residential to Low (3) Residential

A rezoning of the Broward Municipal Services District Zoning Map changing the zoning district of an approximately five (5) acre site, located east of Lyons Road and north of Hillsboro Boulevard and having folio numbers 474232010250, 474232010251, 474232010260, from A-1: Agricultural Estate to PDD.

An Ordinance of the Board of County Commissioners of Broward County, Florida, pertaining to the airport transportation district; amending section 39-352 of the Broward County Code of Ordinances ("Code"), regarding fencing and walls within buffers; and providing for severability, inclusion in the Code, and an effective date.
