The Town of Davie proposes to amend the Code of Ordinances by adopting the following:

AN ORDINANCE OF THE TOWN OF DAVIE, FLORIDA, AMENDING CHAPTER 12, LAND DEVELOPMENT CODE, BY ADOPTING ARTICLE XIX, TIDAL FLOOD PROTECTION; PROVIDING FOR CONFLICT, PROVIDING FOR SEVERABILITY, AND PROVIDING FOR AN EFFECTIVE DATE.

The Town of Davie will hold a public hearing on the proposed ordinance in the Davie Pine Island Park Multipurpose Facility, 3801 S. Pine Island Road (Cypress Room), Davie, Florida on the date hereinafter specified. The item will be discussed at 6:30 p.m. or as soon thereafter as practicable. Comments of any interested party relative to this matter may be submitted in writing and/or presented at the hearing.

The Town Council may continue or defer a hearing to a new date and time certain without further notice, provided the date and time of the continuance or deferral is announced at the hearing.

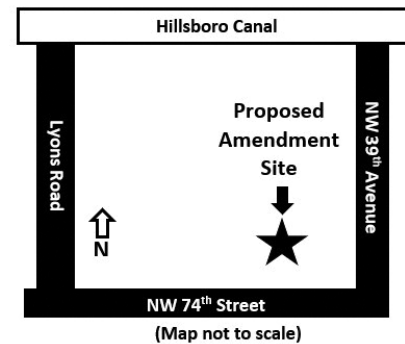

NOTICE OF PUBLIC HEARING TO CONSIDER RECOMMENDATIONS FOR AMENDING THE BROWARD COUNTY COMPREHENSIVE PLAN

In accordance with Section 163.3174, Florida Statutes, the Broward County Resilient Environment Department, Urban Planning Division will conduct a Local Planning Agency (LPA) public hearing on March 16, 2022, at 1:00pm in the 2nd Floor Hearing Room at 1 North University Drive, Plantation, FL, 33324. The purpose of the public hearing is to receive public comments and make a recommendation to the Board of County Commissioners as to whether the following items are consistent with the Broward County Comprehensive Plan:

- An Ordinance of the Board of County Commissioners of Broward County, Florida, pertaining to zoning; amending Chapter 39 of the Broward County Code of Ordinances ("Code"), providing for applicability, definitions, permitted uses, inclusion of provisions related to home-based businesses, fuel retailers, and solar facilities; eliminating certain regulations relating to building design elements; and providing for severability, inclusion in the Code, and an effective date.
- An Ordinance of the Board of County Commissioners of Broward County, Florida, pertaining to the reorganization of the Land Development Code and Zoning Code; amending and renumbering various sections of Chapters 5 and 39 of the Broward County Code of Ordinances ("Code"); and providing for severability, inclusion in the Code, and an effective date.
- A proposed amendment to the Broward County Comprehensive Plan's Future Unincorporated Area Land Use Element Map Series changing the future land use designation of an approximately 5.1 gross acre site, located at 4211 NW 74 Street, from Estate (1) Residential to Low (3) Residential; and providing for an effective date.
