Allison Geiger presented Oliver for care on Wednesday, November 22, 2023. Below is a summary of his visit and treatments at UrgentVet - Boca Raton.

HISTORY:

wont eat, threw up, lethargy

EXAM:

Patient is a 7wk MI feline. Presenting to UrgentVet for vomiting/diarrhea. Owner noticed symptoms began last night. P is a foster kitten that was given to foster at 3 weeks of age, P has been give canned cat food and kitten milk (at night feeding) O states concern for P loosing weight in the past couple days. P was seen for lethargy and diarrhea yesterday at rDVM only a feline leukemia test was performed that came back negative. P was given 1st FVRCP vaccine last saturday and was dewormed. Today P began vomiting acting lethargic and continues to have diarrhea P also hasnt been eating as much but today hasnt wanted to eat but will drink small amounts of water.

Cerenia: Oliver was given a dose of Cerenia, an anti-nausea medication. This will last for 24 hours to decrease nausea and vomiting. If at any time a patient vomits despite this medication or once it has worn off, additional diagnostic testing is recommended.

Be sure to follow the label instructions for any medication(s) dispensed today. If you have additional medication(s) for Oliver at home, please follow the directions given to you by your primary care veterinarian unless otherwise instructed by UrgentVet - Boca Raton. Check with your primary care veterinarian before giving Oliver any non-prescription or over-the-counter medications (e.g., aspirin).

Follow-up Examination:

Please see your primary care veterinarian in 7 days for a recheck.

If there is any vomiting, loss of appetite, nausea, drooling, or obvious pain, please have Oliver rechecked immediately at our hospital or with your primary care veterinarian. Diarrhea will usually resolve after vomiting has ceased. As long as Oliver is eating and drinking well, is being kept quiet and rested, and the diarrhea is not becoming more watery or copious, it should resolve with time, medication, and the bland diet. As diarrhea resolves, you may note a longer than normal time between bowel movements. This is typical following diarrhea. If the diarrhea persists more than 3-4 days, or becomes worse at any time, please recheck sooner with your primary care veterinarian. Further testing and/or therapies may be indicated.

*Due to COVID-19, general practices are booking several days or weeks in advance. Please call your primary veterinarian as soon as you can for this recheck appointment. The successful resolution of a medical condition is often dependent on a timely recheck.

Restrictions in activity:

MILD

• ✓ Restrict activity for 14 days to allow close monitoring. Leash walks only. Absolutely NO running, jumping, or rough play.

We know how difficult it can be to restrict movement in an active pet. If you believe this will be a problem for Oliver, please ask our doctor to prescribe a mild sedative. Complications can often be avoided by preventing excessive activity.

GASTROENTERITIS

General information

Vomiting and/or diarrhea may be caused by primary gastrointestinal (GI) problems. These include foreign material caught in the GI tract, eating something that upsets the GI tract, certain infections or inflammatory conditions of the GI tract, or some cancers that can occur in the GI tract. These signs can also be secondary to problems outside of the GI tract such as toxins, inflammation of the pancreas (pancreatitis), abnormalities in the liver, abnormalities of the neurologic system, problems with the kidneys, or certain conditions with the endocrine system that controls hormones. Often it is recommended to perform radiographs (x-rays) to rule out an obstruction of the GI tract, which would require surgical treatment. It is also often recommended to perform bloodwork to rule out certain conditions outside the GI tract and also to check for changes in blood counts and electrolyte changes that may occur due to fluid loss with vomiting and diarrhea. Supportive care is often necessary to maintain hydration, stop nausea, and help decrease diarrhea. If signs continue or recur despite treatment, often additional diagnostic testing may be recommended.

NORMAL DX: Oliver's testing did not reveal any underlying causes for his signs. We discussed that some parasites can be difficult to detect and dogs can still have intestinal parasites despite a negative fecal examination; for these reasons, we are sending him home with an oral dewormer.

At this time, we are starting Oliver on a probiotic, and an antibiotic. Oliver also received some fluids under the skin and an anti-nausea injection that will last for approximately 24 hours. The anti-nausea medication is a very strong medication and Oliver should not have any more vomiting with this medication on board. If Oliver continues to vomit despite the anti-nausea injection, he needs to be reevaluated immediately as this can indicate a more serious underlying issue.

Supportive care is often necessary to maintain hydration, stop nausea, and help decrease diarrhea. If Oliver is not improving with this treatment, it is recommended to perform radiographs (x-rays) to rule out an obstruction of the GI tract, which would require surgical treatment. It is also often recommended to perform bloodwork to rule out certain conditions outside the GI tract and also to check for changes in blood counts and electrolyte changes that may occur due to fluid loss with vomiting and diarrhea.

Do not feed or offer any water until you get home. You may then offer a small amount of water at a time. If there is no further vomiting you may begin to offer 1-2 Tablespoons of bland food. If Oliver keeps this down you may continue to offer small, frequent meals. You may gradually begin to increase the amount and decrease the frequency fed. After 3 days of bland diet, or once the stool is completely back to normal, you may transition back to normal diet over an additional 3 days by gradually mixing it back in.

METRONIDAZOLE (FLAGYL-ANTIBIOTIC/ANTIPARASITIC)

We are sending home oral Metronidazole a broad spectrum antibiotic and anti-parasitic that treats other parasites such as Giardia and helps with diarrhea. Please give this medication with food

PRO-PECTALIN

We have sent you home with a probiotic called Pro-Pectalin. Pro-Pectalin gel is formulated to help maintain a balanced microbial flora and promote intestinal health. Pro-Pectalin helps maintain proper gut pH supports normal digestive function and aids in reducing occasional loose stools due to environmental stress or changes in diet. Please follow the labeled directions.

PANCUR

You have this medication at home: a broad spectrum dewormer (PANACUR) to empirically deworm Oliver. You will likely need to repeat a deworming medication in 2-3 weeks due to the nature of GI parasites life cycle.

Finally, Oliver should not worsen during treatment. Please monitor Oliver closely until he is eating, drinking, and defecating normally. It may take up to 7 days for the diarrhea to fully resolve. Signs of worsening include continued vomiting, a significant amount of blood present in the diarrhea, abdominal pain, abdominal distention, continued lethargy, or not eating for more than 12-24 hours. If Oliver worsens, additional treatment and diagnostics may be necessary. If you Page 3 of 4

Chronological History Timeline:

Date: 11/21/2023

We brought our foster kitten to Broward Animal Care for a check up and shots on 11/18. He

Seemed a little tired but I thought it was from his shot. On 11/21 he stopped eating and was sleepy.

I texted Desiree and she told me to bring him in. I brought him to Broward Animal Care and they

Examined him, gave him Rebound, and said to keep an eye on him. He started having loose stools

And continued to refuse to eat, and he was sleeping a lot.

Date: 11/22/23

I emailed the ACAD team to ask what else I should do, as he had loose stools, was lethargic, and felt Lighter. He was 1.3 pounds the last time he went to Broward Animal Care. Hannah gave me Directions on gruel feeding, which I started. He continued to have loose stools, which turned into Watery diarrhea. His belly, which was normally round, was flat and wrinkled.

Date: 11/22/23 Evening

As the night progressed, he went downhill. He was extremely lethargic and started vomiting. He Would not eat, would only drink very small amounts of water, and vomited shortly after I gave him Gruel. I did not think he would survive the night. I took him to an emergency vet, where they Gave him subcutaneous fluids and an anti-nausea medication, then started him on Metronidazole And a probiotic. They tested him for Giardia, Coccidia, and any other parasites. When they weighed him, he was 1.22 pounds.

Date: 11/23/23-11/24/23

Thanksgiving day he started to perk up. I continued to give him the Metro and the probiotic.

He started to drink small amounts and did not vomit them. He still had diarrhea but not as often.

He was less lethargic but still sleepy. Friday he was mostly back to his old self. His stools firmed up, he continued to drink and eat small amounts, and he was not vomiting. We continued the Metro And the probiotic for the prescribed time period and he fully recovered.
