✓ December 31, 2024 8:30AM to 11:30AM

Directions to Terminal 2 GTA

- 1. From points 195 North or South, connect with 1595 and proceed East.
- 2. Take the exit for US1 North and head to SE 17th Street.
- 3. Turn right on SE 17th Street and head east to Eisenhower Blvd.
- 4. Turn right on Eisenhower Blvd and proceed to SE 20th Street.
- 5. Turn left on SE 20th Street and proceed to the inspection area.

Requirements at time of Inspection

⇒ Current vehicle registration

Any vehicle in line <u>as of the closing time</u> will be inspected, <u>provided the Division has the required information pertaining to the vehicle</u>. Any vehicle that arrives <u>after closing time will not be inspected</u>.

VEHICLE INSPECTION STANDARDS CHECKLIST

- ✓ Vehicles must be clean and presentable.
- ✓ **Painted surfaces** must be <u>free of grease and ground-in dirt</u> (door jambs, door pillars, door sills, hood, exterior and interior of trunk lids).
- ✓ **Body** should be <u>free of significant dents, creases, nicks, and other types of damage</u>, including both bumpers and the front spoiler/shroud.
- ✓ Windshield free of cracks or chips.
- ✓ Trunk interior should be covered, clean and presentable, with an intact weather seal.
- ✓ Equipment in the trunk must be <u>covered</u> (spare tire, jack, and other).
- ✓ Tires should be of the correct size and have <u>sufficient tread</u> of at least a depth of 2/32".
- ✓ Mechanical equipment, listed below, must be in proper working order:
 - headlights
 - high beams
 - front and rear directional signal lights
 - emergency flashers
 - tail lights
 - back-up lights
 - brake lights including centermounted ("high-hat") lights
- interior (dome) lights must operate automatically when doors open or close
- tag lights
- horn
- windshield wipers (with blades free of tears or excess wear)
- air conditioning (front and rear in luxury limousines and transport vans)
- window and door operators
- √ NO excessive engine smoke.
- ✓ NO vehicle warning indicator lights on; must work to manufacturer specifications.
- ✓ Vehicle's interior should be clean and presentable, including the following:
 - <u>Seat covers, headliners & floor covering</u>: No rips, tears, holes, and cigarette burns, and secured under the door thresholds (sill plates)
 - Door weather seals: Intact
 - <u>Seat belts</u>: Properly working (one pair for each passenger the vehicle can accommodate)

Taxicabs ONLY:

- ✓ **Vehicle's interior** must include a <u>mechanism for displaying the driver's chauffeur's registration</u> (hack license).
- ✓ Exterior surfaces must be <u>based on the color scheme</u> that the Consumer Protection Division approved for each taxicab company. This includes the vehicle's **door jambs and door sills**.
- ✓ Meter must be:
 - Operational, properly sealed if applicable, and clearly visible to passengers.
 - <u>Connected</u> to a properly functioning tell-tale light on the roof of the vehicle.
- ✓ Rate decals must be <u>posted</u> on the inside of the vehicle and clearly visible to all passengers.

Vehicle number must be the <u>same as the permit number</u> (on the rear outside panels, hood, and in the vehicle's interior).
