#### VI. Staff Updates

### A. Upcoming OESBD Events

Staff provided an overview of upcoming events which are also located on the OESBD website. A conversation series on women issues will be held in March to commemorate Women's History Month. County Administrator Monica Cepero will lead the Facebook Live Conversation on "Access to Capital" on March 25<sup>th</sup>. The Broward and Beyond Business Conference will be held on May 6, 2022 at the Signature Grand. The keynote speaker will be Shelby Scales, Director for the U.S. Department of Transportation, Office of Small Business Utilization. She will also conduct a workshop on contracting opportunities for transportation infrastructure projects.
